ORDER

- i) **Mukundpur to Yamuna Vihar (35 stations):** Mukundpur, Azadpur, Shalimar Bagh, Netaji Subash Place, Shakurpur, Punjabi Bagh West, ESI Hospital, Rajouri Garden, Maya Puri, Naraina 2, Naraina 1, Delhi Cantt., Dhaura Kuan, Moti Bagh, Bhikaji Cama Place, Sarojini Nagar, INA, South Extn., Lajpat Nagar, Srinivaspuri, Ashram, Hazrat Nizamuddin, Mayur Vihar, Mayur Vihar Pkt-I, Trilokpuri, Vinod Nagar, I P Extension, Anand Vihar, Jagatpuri, Arjun Nagar, Bhola Nath Nagar, Welcome, Jaffrabad, Maujpur and Yamuna Vihar.


