No. A-32013/3/2009-Admn.I: Consequent upon their inclusion in the Select List of 2003 for the Grade-I (Under Secretary) of the Central Secretariat Service (CSS), as per orders contained in the Department of Personnel & Training's OM No. 5/16/2007-CS.I dated 25.08.2009, the President is pleased to appoint the following officers of this Ministry to the Grade-I of CSS on regular basis in the Select List year 2003:

The seniority of above officers included in the aforesaid Select List will be in the same order in which their names have been arranged, irrespective of actual dates of their appointment to the Grade I. The appointment of officers included in the aforesaid Select List, to the grade of Under Secretary, on regular basis, shall be subject to the final outcome in the CWP No. 13352/2005 in the High Court of Delhi.

3. The above appointments are deemed to have been made effective w.e.f. 01.07.2003 for the purpose of approved service and for fixation of pay as Under Secretary on notional basis. The actual benefits, however, would be available only from the date the officers were / are so appointed to the grade of Under Secretary of CSS.

4. The above officers will be entitled to arrears on account of re-fixation of their pay from the dates of their actual appointment to the post of Under Secretary and entitled to exercise the benefit of option for fixation of pay under the provision of FR-22, within one month from the date of issue of this Notification. However, such officers, who were promoted as ad-hoc Under Secretary prior 1st July of 2003 and had availed the benefit of split option, shall not be eligible to re-exercise the option.
